1. **Panchapuri Municipality** invites electronic bids from Nepalese eligible bidders for the construction of **Kalapani-Baraiche-Chanali Road** under National Competitive Bidding procedures. The estimated amount for the works is Nrs. **88,65,964.84**[without Vat].

Bidders, submitting their bid electronically, should deposit the cost fee of Nrs. **3000** till **2078/11/09** during office hours of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Electronic bids must be submitted to the office of **Panchapuri Municipality, Babiyachaur Surkhet** through PPMO website **www.bolpatra.gov.np/egp** or before **12:00pm** on **2078/11/12**. Bids received after this deadline will be rejected.
5. The bid will be opened in the presence of Bidders' representatives who choose to attend at **2:00pm** on **2078/11/12** at the office of **Municipality, Babiyachaur Surkhet**.
6. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of Nrs. **2,55,000**, which shall be valid for 30 days beyond the validity period of the bid (i.e 120 days).
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
