Invitation for Bids for the Hasegaun Drinking water supply final stage project

1. The Government of Nepal *has allocated funds* towards the cost of Hasegaun Drinking water supply final stage project and intends to apply part of the funds to cover eligible payments under the Contract for PMO/SKT/NCB/WORKS/DWS/078/079-08. Bidding is open to all eligible as per Section V of bidding document.
2. Panchapuri Municipality, Surkhet invites electronic bids from eligible bidders for the construction of Hasegaun Drinking water supply final stage project under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 5,00,00,000**
 - Minimum Work experience of similar size and nature: **Construction of one water supply Project of value Nrs. 2,00,00,000 each within last 10 years.**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

5. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document Nrs. 10,000.00 in the Project's Rajaswa (revenue) account as specified below.

6. Pre-bid meeting shall be held at office of panchapuri municipality at 1:00 pm and 2077/11/19.. Electronic bids must be submitted to the office **Panchapuri Municipality, Surkhet** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **2078/11/29** at 12:00 PM. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 PM** on **2078/11/29** at the office of **Panchapuri Municipality**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Nrs. 6,43,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
