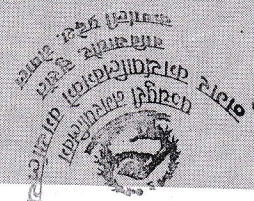

5. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before 12:00 Hrs on 2079/12/15 (29th Mar, 2023).
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hrs on 2079/12/15 (29th Mar, 2023). at Division Forest Office, Pahalmanpur. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a Scanned Copy of bid security in pdf format, which shall be valid for 30 days beyond the validity period of the bid.
